

## Self Declaration Form (To be completed by Trekker/Participant)

- 1. RoamingIndian Adventure activities come with inherent risks, especially considering the terrain, weather, and high altitudes. Possibilities of slips, falls, injuries, sickness, and even fatal accidents cannot be ruled out.
- 2. Participants should possess good health and stamina and must not conceal or misrepresent any information about their health, as poor health can significantly increase the risks associated with these Adventure activities.
- 3. To facilitate such extensive operations, RoamingIndian collaborates with third-party professionals. RoamingIndian will not be liable for any damage, loss, or harm to your belongings, luggage, or yourself while being transported by porters, ponies, or vehicles, during the trip, your arrival and departure, or your stay at a hotel/guest house.
- 4. Participants are expected to maintain acceptable behavior conducive to group travel. RoamingIndian reserves the right to terminate your trip if you cause distress or annoyance to fellow travelers, damage property belonging to any supplier, or engage in smoking or alcohol consumption. In such cases, no refunds for unused services will be provided.
- 5. The rules, regulations, and guidelines have been established to ensure safe enjoyment of the activity/trip. Participants must adhere to the instructions provided by the Trip leader/organizer, whose decisions will be final and binding.
- 6. RoamingIndian prioritizes participant safety and enjoyment, and takes its responsibilities seriously to ensure trouble-free trips. RoamingIndian reserves the right to modify the activity/trip or any part thereof under various circumstances, including acts of God, road closures, political unrest, illness, accidents, and events beyond RoamingIndian's control. Any additional costs arising from such circumstances shall be borne by the participants on-site.
- 7. RoamingIndian is not responsible for any medical expenses or evacuation costs incurred by participants during or after the Adventure activity/trip.

I absolve RoamingIndian wholly or partly from any liability in case of accidents, illnesses, injuries, or death during this activity/trek.
